

Proposed closure of the boarding provision at Fred Nicholson School by 31 August 2023

Background

Fred Nicholson Foundation Special School is a local authority maintained special education needs school for boys and girls, aged 3 – 19 years, in Dereham, Norfolk.

The school currently has 174 children on roll, 18 of whom were staying overnight in the boarding provision for between one and four nights each week. The boarding provision is situated in the main school building and provides separate accommodation for boys and girls within open plan dormitories. The school caters for children with moderate and severe learning difficulties and associated complex needs such as speech and language disorders, sensory, physical and mental health needs including autism spectrum and neurodiverse conditions. The layout within the current residential provision limits the number of pupils able to access boarding. The residential environment is unable to appropriately meet the needs of the full range of complex difficulties within the cohort of the school. The main communal area is on the first floor of the school.

The school has a 'Good' Ofsted rating when they were inspected in November 2019. The residential inspections have had an annual 'good' rating since 2016. The most recent Ofsted was undertaken in May 2022 and rated 'Good'.

Our Proposal

Norfolk County Council is consulting on a proposal to close the boarding provision at Fred Nicholson School, Dereham, from 31 August 2023.

If this proposal is agreed, we plan to bring forward the increase of pupil places, currently being consulted on, as part of the plans to relocate Fred Nicholson School to a site in Swaffham. This would not be an increase of all the pupil places in one term, but phased over several terms, so the school gradually grows. The space currently reserved for boarding would be repurposed and made available to create additional teaching and learning space for the additional pupils, from 1 September 2023.

Boarding provision at Fred Nicholson School

Fred Nicholson has not been able to offer any of its potential 26 boarding spaces for the last 7 weeks.

When all staff are recruited there can be a maximum of 26 pupils across the four nights. The ages and genders of the young people residing dictates how many young people stay at any one time, according to the national statutory minimum standards. Due to poor recruitment responses over the past five years the care team numbers have diminished, impacting the ability to run at capacity.

There are currently 6 full time staffing vacancies including the Manager and Deputy Manager role. In accordance with statutory regulations Governors had to temporarily suspend this provision on 10th February 2023 at which time it was attended by 18 pupils.

Why are proposing closure of this provision

Norfolk County Council recently undertook a review of Education Boarding in the county. This found that whilst there was a level of benefit educationally for pupils, the review did not find that boarding was essential for pupils to meet their educational outcomes.

However, it is clear that there are social care sufficiency needs around support for families with SEND children in the west of the county. It is therefore proposed to investigate future residential provision, with a social care focus e.g. short breaks for children and their families in the west of Norfolk.

If the boarding provision at the school is decommissioned and removed from 31 August 2023 we plan to;

➤ Refurbish the space currently utilised for residential to accommodate pupils in a new Sixth form provision, already planned as part of the proposed school expansion. As is currently the case for Fred Nicholson School, appropriate pupils for the Sixth form provision would be identified using the SEND admissions process. Further details on the admissions process can be found on Norfolk's Local Offer site.

For any remaining care staff it is possible that job offers can be made at the school itself however HR guidance will be sought and followed.
