



Consultation on Proposal to Expand King's Lynn Academy to add 300 more places from 1 September 2025

Our Proposal

Eastern MAT is proposing to expand King's Lynn Academy, Queen Mary Road, King's Lynn, Norfolk, PE30 4QG, to add 300 pupil places from 1 September 2025. This will be a phased increase over time.

Why do we need to expand?

There are currently in excess of 500 homes expected to be built in the next 6 years, which will increase the current resident/catchment area of King's Lynn Academy. This growth means we would not be able to accept the expected increase in pupil numbers, within our current school site.

Our proposal is in response to this increased housing and we are working with Norfolk County Council to meet this demand in pupil places, by proposing these additional secondary school places at King's Lynn Academy.

The County Council has a statutory duty (Section 14, Education Act 1996) to plan and secure sufficient school places for their area to meet the needs of its children and families and therefore it is obliged to plan for the expansion of its school capacity.

They have identified that growth continues to build from the effects of both catchment increases and high preference patterns and King's Lynn Academy has the site capacity to allow expansion compared to the other two secondaries which support this area.

Eastern MAT sees the proposed expansion of the school as an opportunity to both meet the increasing demand for places in the local area and to develop the infrastructure, improve the existing facilities and invest in the site.

Our proposal will see the school grow from 6 FE (forms of entry) to 8FE. This means that each September from 2025, our intake in Year 7 will increase from 180 pupils to 240 pupils. The earliest that this would start is 1 September 2025.

It is hoped that the additional 300 pupils in total, will meet the demand in the area and it is not envisaged that the proposed expansion will impact on neighbouring schools.

Capital Programme

King's Lynn Academy has been assessed as having a sufficient site to allow for this expansion.

A capital project, funded by Norfolk County Council will involve;

- Expanding the current dining hall and kitchen
- Small amount of remodelling within the school, to increase the number of classrooms
- Enlarging the library space using existing rooms
- Building a new CDT block on hard surface area, located beside the South Quadrangle
- Provision of additional car parking spaces.

Every effort will be made to minimise disruption for pupils, parents and neighbouring residents during building works. For instance, scheduling as much work as possible during school holiday periods and contractors will work with the school to minimise noise during exam time.

Impact on staff and pupils

The expansion of King's Lynn Academy will generate greater financial efficiencies to allow for recruitment of new staff and also the retention of our current staff.

As a Trust, Eastern MAT is keen to support and develop staff, to make the most of the new opportunities at King's Lynn Academy.

The health and safety of staff and pupils, during the capital programme phase, will be a key element of discussions with contractors and capital works will be scheduled as much work as possible during school holiday periods. This will ensure that disruption for existing staff and pupils from any building works will be kept to a minimum.

Eastern MAT's priority is to ensure that pupils have high quality, fit for purpose accommodation and learning facilities.

School budgets

School budgets are based on a number of factors, including the number of pupils. An increase in pupil places will result in an increase in budget and associated costs.

Transport implications and safe routes to school

King's Lynn Academy will be expected to provide and if necessary, review their travel plan as part of the expansion plan.
