

Have your say on our plans for Wymondham Recycling Centre; a new recycling centre for South Norfolk

Overview

Our plans for Wymondham Recycling Centre, a new recycling centre for South Norfolk, are now available for people to look at and feed back their thoughts.

Why your views matter

We would like to hear your thoughts on how well the design meets your needs before we take our plans through the planning process. We would also like some information about how you might use the site, to help us make sure it meets your needs.

A brand new recycling centre in Wymondham

We're planning a new recycling centre near Wymondham to replace the current site. We've been looking for land that is suitable for a new recycling centre, and in January 2022 Norfolk County Council agreed to move forward with a site located on land off the B1172 London Road.

Norfolk County Council provides 20 recycling centres for residents to bring their waste for reuse, recycling, composting and disposal. We accept a wide range of household waste at our recycling centres **for free** such as garden waste, furniture, carpets, general waste, electrical items, cardboard, paper, metals, textiles and cooking oil, with a full list available on our website. Recycling Centres have additional facilities for the disposal of DIY type construction and demolition waste and, at some sites, trade waste. Reuse shops, located on most sites, are a great place to donate and buy items, from books and DVDs, to bikes and small furniture.

Why are we moving?

With lots of planned housing growth around Wymondham and Attleborough, we want to provide a site with improved access that is a larger, modern site and that does not need to close during the day for the site to be serviced. Norfolk County Council is investing £2.2m in the new Wymondham Recycling Centre.

The site search

We looked for a site that:

- Is big enough for separate areas for the operating vehicles and the public, a good drainage system, site office, reuse shop and parking for the public and the site staff.
- Could take up to 6,000 tonnes of waste a year to allow for current volumes of waste and for future growth.
- Provides suitable access and good road links for public and service vehicles.
- Could be available for access seven days a week.

The proposed site

The new site is located on land off the B1172 London Road and will replace the current Wymondham Recycling Centre



The New Site

Key features planned for the new site:

- A split-level site providing step free access to containers
- Separate service area so the site does not need to close for essential waste collection and servicing operations
- More parking spaces including dedicated staff car and cycle parking
- A reuse shop
- Pay as You Throw service for disposal of construction and demolition waste
- Trade service for small businesses

We've incorporated these features into our plans, and we want you to tell us what you think of the proposed site layout, so we can refine it before we submit a planning application.

What will it take?

You can recycle over 20 different materials at the current Wymondham Recycling Centre and the new site will take all the materials you can currently bring. The larger space means we can add in extra containers for the more popular waste streams, like green waste and non-recyclables and we'll have more space to accept some additional items including

- Flat Glass
- Plasterboard
- Tyres

- Items for reuse
- Trade waste

We hope to be able to separate even more materials in future as markets become available for the recycled materials.

The new site will have a reuse shop so you can donate, and buy, items suitable for reuse on site.

Planning and the environment

Following the public consultation, we will prepare a planning application for a new recycling centre. This will be submitted to Norfolk County Council planning services. A number of reports will accompany the application, including:

Traffic and Transport

The recycling centre will be accessed from the B1172 London Road. We will carry out traffic surveys at the existing Wymondham Recycling Centre to monitor vehicle numbers and patterns of usage across the week. This information, combined with other data we have on recycling centre usage and local traffic data will be used to assess the impact of the proposed new site.

Ecology and Landscape

The site is currently unused and sits next to the National Highways depot with the A11 running behind it. There are established trees around the site, providing good screening. A landscape assessment and plan will be included as part of our application.

A preliminary ecological appraisal is being undertaken to understand the existing ecology on the site and identify whether there are any protected species there.

Sustainability

Norfolk County Council has a target to achieve net zero carbon by 2030. We will be looking at how we can include sustainability measures within our design to minimise the impact of the site operations. Being able to collect and separate more materials for recycling instead of sending them for disposal is important in reducing our carbon footprint. Some of the measures we'll consider include solar panels, rainwater harvesting for toilets, low energy lighting and electric vehicle charging for staff cars.

Flood Risk and Drainage

We need to ensure that we have suitable drainage on site including for the treatment of the surface water run off on site. The drainage needs to be designed to deal with storm events and also water used in the event of a fire on site.

In order to make sure we design suitable drainage we are carrying out some investigations of the ground conditions

Odour and Noise

Waste will be stored in containers and taken off-site for disposal or recycling when they are full. The site will be carefully managed to ensure that full containers are taken away quickly so the site can operate smoothly. As waste is not on site for long, it reduces the risk of odour.

As part of the planning application we will assess the noise that some of the onsite plant and machinery typically produce.

We expect our site operator to maintain very high standards of cleanliness when operating the site, including regular litter picking, and we visit the sites regularly to check that standards are being maintained.

Environmental Permit

We will apply to the Environment Agency for a permit to allow the site to operate. The permit will set out rules that that our site operators will need to follow, including how much waste we can take and store on site, what we do with the waste and ensuring our site is safe, secure and does not harm the environment.

As part of our application to the Environment Agency, we will need to produce a Fire Prevention Plan to demonstrate that the site is being operated safely to avoid the risk of fire and detail what we will do if a fire breaks out on site. Once operating, the site will regularly be monitored by Norfolk County Council and the Environment Agency.

Opening Hours and Lighting

We are proposing that the new site will operate on a full time basis, and that the hours will match those of the service across the County. These are currently 9am to 5pm (1 April - 30 September) and 9am to 4pm (1 October - 31 March).

The application will allow for the site to be serviced from 7am.

There will be some external lighting on the site for safety and security purposes.
