

**The Norfolk County Council
(Norwich City Centre Controlled Parking Zone)
(Castle Meadow, Red Lion Street, St Stephens Street)
Amendment Traffic Regulation Order 2022**

The Norfolk County Council in exercise of powers under sections 1, 2, 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as The Norfolk County Council (Norwich City Centre Controlled Parking Zone) (Castle Meadow, Red Lion Street, St Stephens Street) Amendment (Traffic Regulation Order 2022 and shall come into effect for all purposes on the 17th day of October 2022.

2. The Norwich City Council City Centre Controlled Parking Zone (Consolidation) Traffic Regulation Order 2003 (as amended) (hereinafter referred to as the "2003 Order") is amended as set out in Articles 3 to 9 in this Order.

3. Article 5 of the 2003 Order is deleted and replaced with the following wording:-

"Bus Clearways

5. No person shall cause or permit any vehicle other than a bus to wait in the lengths of road specified as bus clearways in Schedule 16 as defined in Part 6 and marked in accordance with diagram 1025.1 of the Traffic Signs Regulations and General Directions 2016 at any time."
4. References to Castle Meadow and St Stephens Street in Schedule 15 of the 2003 Order are amended as specified in Schedule 1 of this Order.
5. References to St Stephens Street in Schedule 16 of the 2003 Order are amended as specified in Schedule 2 of this Order.
6. References to Castle Meadow in Schedule 27 of the 2003 Order are amended as specified in Schedule 3 of this Order.
7. References to Castle Meadow, Red Lion Street and St Stephens Street in Schedule 61 of the 2003 Order are amended as specified in Schedule 4 of this Order.
8. References to Red Lion Street in Schedule 95 of the 2003 Order are amended as specified in Schedule 5 of this Order.
9. References to Castle Meadow and St Stephens Street in Schedule 120 of the 2003 Order are amended as specified in Schedule 6 of this Order.
10. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.


