(30 M.P.H. SPEED LIMIT) ORDER 1998

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and part III of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
- 2. The Norfolk County Council (Little Melton) (30 m.p.h. Speed Limit) Order 1986 is 133 hereby revoked.
- This Order comes into operation on the 13th day of February, 1998 and may be cited as The Norfolk County Council (Little Melton) (30 m.p.h. Speed Limit) Order 1998.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

C169 Great Melton Road - from its junction with the U78008 Mill Road westwards for a distance of 435 metres.

C169 The Street - from its junction with the U78008 Mill Road eastwards to its junction with the U78009 Green

Lane.

C169 School Lane - from its junction with the U78009 Green Lane

north eastwards to its end on the southwest side

of the A47 Trunk Road.

U78008 Mill Road - from its junction with the C159 Great Melton

Road northwards and westwards to a point 170 metres west of its junction with the U78362 Ringwood Close and including the leg running northwards to a point in line with the north

boundary of No. 46 Mill Road.

from its junction with the U78135 Braymeadow Lane for its entire length.
