

THE NORFOLK COUNTY COUNCIL
(BLOFIELD, HEMBLINGTON AND PEDHAM, VARIOUS ROADS)
(30 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2015

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedules below, at a speed exceeding 30 miles per hour.
2. The following Orders will become revoked on the date of commencement of this Order as follows:-

"The County Council of Norfolk (Restricted Roads)(No 1) Order 1976" – insofar as its entry for Blofield Road, Stocks Lane and Brundall Road in the Parishes of Blofield and Brundall in the Schedule to that Order refers to the entries for Brundall Road and Stocks Lane in Schedule 1 to this Order;

"The Norfolk County Council (Blofield)(30 m.p.h. Speed Limit) Order 2004" – in its entirety;

"The Norfolk County Council (Blofield, Fox Lane)(30 m.p.h. Speed Limit) Order 2003" – in its entirety;

"The Norfolk County Council (Blofield)(30 m.p.h. Speed Limit) Order 2002" – in its entirety;

"The Norfolk County Council (Blofield)(30 m.p.h. Speed Limit) Order 1997" – in its entirety;

"The Norfolk County Council (Hemblington, Pedham and Blofield)(30 m.p.h. Speed Limit) Order 1995" – in its entirety.

"The Norfolk County Council (Blofield, Yarmouth Road)(30 m.p.h. Speed Limit) Order 2015" – in its entirety.

"The County Council of Norfolk (Restricted Roads)(No 1) Order 1976" – insofar as that Order refers to its entries for the Parish of Blofield and its entries for Brundall Road and Stocks Lane in the Parishes of Blofield and Brundall.

3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This Order comes into operation on the 27 day of November 2015 and may be cited as The Norfolk County Council (Blofield, Hemblington and Pedham, Various Roads)(30 m.p.h. Speed Limit) Order 2015.

5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.
