THE NORFOLK COUNTY COUNCIL (YAXHAM)

(30 M.P.H. SPEED LIMIT) ORDER 1996

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2) and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
2. The following Orders are hereby revoked insofar as they relate to the lengths of road specified in the Schedule.  
  
The County Council of Norfolk (Built Up Areas) Order 1936.  
The County Council of Norfolk (Built Up Areas) No. 3 Order 1936.  
The County Council of Norfolk (Built Up Areas) (No. 1) Order 1949.
3. This Order comes into operation on the 4th day of October, 1996, and may be cited as The Norfolk County Council (Yaxham) (30 m.p.h. Speed Limit) Order 1996.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE

In the Parish of Yaxham

- B1135 - from a point 20 metres north of its junction with U35006 southwards and eastwards to a point 90 metres south of its junction with C200 Norwich Road.
- C200 Station Road - from its junction with the B1135 south westwards to a point 55 metres west of the access road to Railway Farm.
- C200 Norwich Road - from its junction with the B1135 eastwards to a point 145 metres east of its junction with U35239 St. Peters Close and from a point 120 metres west of its junction with U35007 Spring Lane eastwards and north eastwards to a point 30 metres north east of its junction with U35006 ~~Cuthroat Lane~~ PADDOCKET
- U35009 Church Lane - for its entire length.
- U35239 St. Peters close - for its entire length.
- U35281 Elm Close - for its entire length.
- U35018 Stone Road - from its junction with C200 Norwich Road south eastwards for a distance of 130 metres.

- U35007 Spring Lane - from its junction with C200 Norwich Road northwards for a distance of 45 metres.
- U35021 Well Hill - from its junction with C200 Norwich Road south eastwards for a distance of 330 metres.
- U35006 Cutthroat Lane - from its junction with C200 Norwich Road northwards for a distance of 150 metres.
