## THE NORFOLK COUNTY COUNCIL (SOUTH CREAKE)

# (30 M.P.H. & 40 M.P.H. SPEED LIMIT) ORDER 1997

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 miles per hour.
- 2. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 2 to this Order as a speed exceeding 40 miles per hour.
- 3. The County Council of Norfolk (Built Up Areas) (No. 11) Order 1950 is hereby revoked.
- 4. The following Orders are hereby revoked insofar as they relate to the lengths of road specified in the Schedule.

The County Council of Norfolk (Built up Areas) (No. 4) Order 1948.

The County Council of Norfolk (40 m.p.h. Speed Limit) (No. 2) Order 1967.

The County Council of Norfolk (Restricted Roads) (No. 3) Order 1980.

- 5. This Order comes into operation on the 31st day of January 1997, and may be cited as The Norfolk County Council (South Creake) (30 m.p.h. Speed Limit) Order 1997.
- 6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
