

**THE NORFOLK COUNTY COUNCIL
(BRANCASTER STAITHE, VARIOUS ROADS)
(20 M.P.H. AND 30 M.P.H. SPEED LIMITS ORDER 2019**

The Norfolk County Council in exercise of its powers under Sections 82(2), 83(2), 84(1) and (2), 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Brancaster Staithe, Various Roads) (20 m.p.h. and 30m.p.h. Speed Limits Order 2018 and shall come into effect on the 13th day of May 2019.
2. Schedule 2 of The Norfolk County Council (Brancaster) (30 & 40 m.p.h. Speed Limit Extensions) Order 1995 is hereby revoked on commencement of this Order.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the length of road specified in Schedule 1 to this Order.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the length of road specified in Schedule 2 to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

2P137 School Pastures	-	For its entire length.
C99 Whiteway Road	-	From its junction with the A149 Main Road for a distance 185 metres south/eastwards.
