Norfolk County Council has to maintain highways and this includes roads, footpaths and verges, making them safe for road users.



We spray weeds on some roads and pavements, and also deal with ragwort, thistles, nettles, brambles and giant hogweed on the highway.

Norfolk County Council are proposing to save money by treating weeds on our highways once a year, rather than twice.



This proposal would save us £130,000 in 2023/24.






