

**THE NORFOLK COUNTY COUNCIL (DICKLEBURGH, HARVEY LANE)
(30 M.P.H. AND 40 M.P.H. SPEED LIMIT) AMENDMENT ORDER 2020**

The Norfolk County Council in exercise of its powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Dickleburgh, Harvey Lane) (30 m.p.h. and 40 m.p.h. Speed Limits) Amendment Order 2020 and shall come into effect on the 8th day of June 2020.
2. Schedule 1 of The Norfolk County Council ((Dickleburgh) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1999 (hereinafter referred to as the "1999 Order") as amended by The Norfolk County Council (Dickleburgh and Rushall, Various Roads) (20 m.p.h. Speed Limit) Order 2005 is amended as specified in the Schedule to this Order.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the lengths of road as specified in the Schedule to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
