# THE NORFOLK COUNTY COUNCIL (KING'S LYNN AND NORTH AND SOUTH WOOTTON, VARIOUS ROADS) (30 M.P.H. AND 40 M.P.H. SPEED LIMITS) ORDER 2012

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in Schedule 1 below, at a speed exceeding 30 m.p.h.
- 2. No person shall cause or permit any vehicle to proceed along the length of road specified in Schedule 2 below at a speed exceeding 40 m.p.h.
- 3. The following Orders will become revoked on the date of commencement of this Order as follows:-
  - "The Norfolk County Council (The Birches, South Wootton)(30 m.p.h. Speed Limit) Order 1986" in its entirety;
  - "The County Council of Norfolk (40 m.p.h. Speed Limit) (No 2) Order 1970" in its entirety;
  - "The County Council of Norfolk)(40 m.p.h. Speed Limit) (No 1) Order 1973" in its entirety;
  - "The Norfolk County Council (North and South Wootton, Various Roads)(30 m.p.h. Speed Limit) Order 2010" in its entirety;
  - "The Norfolk County Council (Kings' Lynn, A1078 Edward Benefer Way)(30 m.p.h. and 40 m.p.h. Speed Limits) Order 2005" in its entirety;
  - "The Norfolk County Council (King's Lynn, Wootton Road)(30 m.p.h. Speed Limit) Order 2001" in its entirety.
- 4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations"
- 5. This Order comes into operation on the 11<sup>th</sup> day of January 2013 and may be cited as The Norfolk County Council (King's Lynn and North and South Wootton, Various Roads)(30 m.p.h. and 40 m.p.h. Speed Limits) Order 2012.
- 6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.
