THE NORFOLK COUNTY COUNCIL (DISS)
(30 M.P.H. AND 40 M.P.H. SPEED LIMIT) ORDER 2000

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2) and 84(1) and (2) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule to this Order at a speed exceeding 30 m.p.h.
2. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 2 to this Order at a speed exceeding 40 m.p.h.
3. The following Order will become revoked on the date of commencement of this Order as follows:-

"The County Council of Norfolk (Restricted Roads) No. 1. Order 1963" - in its entirety;

"The Norfolk County Council (Various Roads, Diss) (30MPH Speed limit) Order 1991" - in its entirety.

"The Norfolk County Council (A143 Rose Lane, Diss) (30 MPH Speed Limit) Order 1992" in its entirety

4. This Order comes into operation on the 8th day of September 2000 and may be cited as The Norfolk County Council (Diss) (30 m.p.h. and 40 m.p.h. Speed Limit) Order 2000.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

B1077 Stuston Road

from its junction with A1066 Victoria Road south-eastwards for a distance of 210 metres.

B1077 Shelfanger Road	from its junction with the U76012 Factory Lane northwards to a point 30 metres north of its junction with U76013 Louies Lane.
C579 Rose Lane/Lower Rose Lane	from its junction with A1066 Victoria Road south-westwards to a point 180 metres southwest of its junction with U71425 Riverside Maltings.
C472 Heywood Road/Burston Road	from its junction with U76270 Walcot Road northwards and eastwards to a point 210 metres east of its junction with U76269 Heywood Road
U76269 Heywood Road	from its junction with C472 Burston Road northwards for a distance of 45 metres.
U76276 Lower Denmark Street	from its junction with U71021 Riverside southwards for a distance of 30 metres.
U76270 Walcot Road	from its junction with C472 Heywood Road eastwards to a point 295 metres east of its junction with the U70006 Uplands Way.
U76013 Louies Lane	for its entire length
U76012 Factory Lane	for its entire length
B1132 Roydon Road	from a point 140 metres east of its junction with A1066 eastwards to its junction with B1077 Shelfanger Road.
U76011 Brewers Green Lane	from its junction with B1132 Roydon Road north-westwards for a distance of 220 metres.
U76231 Tottington Lane	from its junction with U70023 Denmark Lane eastwards for distance of 330 metres.
U70023 Denmark Lane	from its junction with A1066 Stanley Road southwards for its entire length.
U76603 Denmark Lane	from its junction with A1066 Stanley Road northwards for its entire length

SCHEDULE 2

In the Town of Diss

40 m.p.h. Speed Limit

U76270 Walcot Road	from a point 295 metres east of its junction with the U70006 Uplands Way eastwards to its junction with the U76273 Walcot Green.
