

**THE NORFOLK COUNTY COUNCIL
(KING'S LYNN, SOUTH QUAY AREA (KR02))
(RESTRICTED ZONE) AMENDMENT ORDER 2017**

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(1) and (2), 32(1) and 35(1), 45 and 46 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as the "The Norfolk County Council (King's Lynn, South Quay Area (KRO2)) (Restricted Zone) Amendment Order 2017 and shall come into effect for all purposes on 10th day of April 2017.

2. The Norfolk County Council (King's Lynn, South Quay Area (KR02)) (Restricted Zone) Order 2016 is amended as specified in Articles 3 and 4 of this Order.

3. In Schedule 1 the lengths of South Quay are added as specified in Schedule 1 of this Order to prohibit vehicles to wait at any time on those lengths of road.

4. In Schedule 2 the lengths of South Quay set out in Schedule 2 of this Order will be subject to the amended scale of charges for a Residential Zone Pay and Display Parking Ticket and Restricted Zone Virtual Parking Ticket as set out in Schedule 3 of this Order.

5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, the provision of this Order shall prevail.
