## THE NORFOLK COUNTY COUNCIL (NARBOROUGH, DENNYS WALK) (20 M.P.H. SPEED LIMIT ZONE) AMENDMENT ORDER 2018

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2)/84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with the Act, hereby make the following Order:-

- This Order may be cited as the Norfolk County Council (Narborough, Dennys Walk) (20m.p.h. Speed Limit Zone) Order 2018 and shall come into effect on the 19<sup>th</sup> day of February 2018.
- 2. The Norfolk County Council (Narborough) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1996 (hereinafter referred to as the "1996 Order") is amended in Schedule 1 by the amendments to Dennys Walk as specified in Schedule 1 to this Order.
- 3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in Schedule 2 to this Order.
- 4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
