

THE NORFOLK COUNTY COUNCIL (VARIOUS ROADS, REEPHAM)

(30 M.P.H. SPEED LIMITS) ORDER 1995

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
2. The following Orders is hereby revoked insofar as it refers to the lengths of road specified in the schedule to this Order:-

3. This Order comes into operation on the 29th day of April 1995, and may be cited as The Norfolk County Council (Various Roads, Reepham) (30 m.p.h. Speed Limits) Order 1995.

.. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

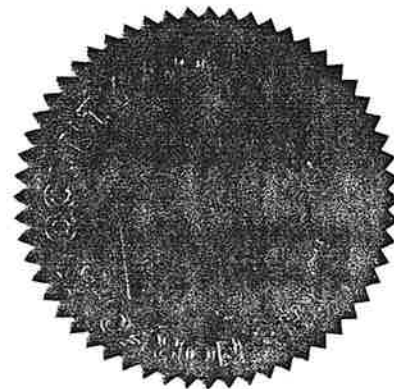

B1145, Cawston Road	-	from its junction with U57283 Orchard Lane for a distance of 208 metres north-eastwards.
U57284, The Moor	-	from its junction with U57283 Orchard Lane/The Moor eastwards for a distance of 326 metres.
C267, Wood Dalling Road	-	from its junction with B1145 Station Road north eastwards, to a point 25 metres north east of World's End Lane.
U57283, Orchard Lane/ The Moor	-	from C260 The Moor/New Road to B1145 Cawston Road/Station Road.
U57279, Broomhill Lane	-	from C266 Whitwell Road westwards for 195 metres.
C266, Whitwell Road	-	from its junction with U57279 Broomhill Lane south-westwards for a distance of 153 metres.
U57102, Mill Road	-	from its junction with C266 Whitwell Road southwards for 297 metres.
U57280, Rudd's Lane	-	entire length.
U57282, The Street	-	from U57102, Mill Road eastwards, southwards and south-westwards for 825 metres.
U57022, Smuggler's Lane	-	entire length

Kerdiston Road                      from B1145 Station Road to a point 20 metres north west of  
Smuggler's Lane.
