THE NORFOLK COUNTY COUNCIL (WESTON LONGVILLE, VARIOUS ROADS) (20 M.P.H. SPEED LIMIT) ORDER 2017

The Norfolk County Council in exercise of its powers under Sections 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 198, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as The Norfolk County Council (Weston Longville) (20 m.p.h. Speed Limit) Order 2017 and shall come into effect on the 27th day of November 2017.
- 2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
- 3. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 4. The Norfolk County Council (Weston Longville) (30 M.P.H. Speed Limit) Order 1996 is hereby revoked.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, the provision of this Order shall prevail.
