

**THE NORFOLK COUNTY COUNCIL
(WESTON LONGVILLE, VARIOUS ROADS)
(20 M.P.H. SPEED LIMIT) ORDER 2017**

The Norfolk County Council in exercise of its powers under Sections 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 198, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Weston Longville) (20 m.p.h. Speed Limit) Order 2017 and shall come into effect on the 27th day of November 2017.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
3. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The Norfolk County Council (Weston Longville) (30 M.P.H. Speed Limit) Order 1996 is hereby revoked.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, the provision of this Order shall prevail.

SCHEDULE
In the Parish of Weston Longville

20 m.p.h. Speed Limit

U51245 Church Farm Close	-	For its entire length.
U57040 Church Lane (known locally as Ringland Lane)	-	from its junction with C167 Church Street/Marl Hill Road eastwards for a distance of 145 metres.
U57161 Field Road	-	from its junction with C167 Church Street north-westwards for a distance of 70 metres.
U57317 Link Road	-	from its junction with C167 Woodforde Close/Church Street south-eastwards for a distance of 70 metres.
U57299 Post Office Lane	-	For its entire length.

C167 Woodforde Close/Church Street/Marl Hill Road (known locally as Honingham Road/Woodforde Close/Church Street)	- from a point 117 metres southwest of the centre line of U57299 Post Office Lane, north-eastwards to a point 305 metres northeast of the centre line of U57040 Church Lane (known locally as Ringland Road).
