

The Norfolk County Council
(Wymondham, Various Roads) (Whispering Oaks Estate)
(20 mph Speed Limit Zone) Consolidation and Variation Order 2025

Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as The Norfolk County Council (Wymondham, Various Roads) (Whispering Oaks Estate) (20 mph Speed Limit Zone) Consolidation and Variation Order 2025 and shall come into effect on the 4th day of August 2025.
2. No person shall cause or permit any motor vehicle to proceed along the lengths of the roads specified in the Schedule to this Order at a speed exceeding 20 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The following Orders will be revoked and consolidated into this Order on the commencement of this Order:
 - i. The Norfolk County Council (Wymondham, Various Roads) (20 m.p.h. Speed Limit Zone) Order 2013; and
 - ii. The Norfolk County Council (Wymondham, Various Roads) (20 m.p.h. Speed Limit Zone) Order 2016
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of the roads specified in the Schedule to this Order, that provision of this Order shall prevail.



U71737 Daisy Street	-	From its junction with the U71739 Pelargonium Drive southwards to its junction with the U71734 Snowdrop Street

U71736 Daffodil Close	-	From its junction with the U71719 Honeysuckle Square north-westwards for its entire length including the turning heads
U7P809 Duffin Drive	-	From its junction with the U71694/U7P806 Lavender Road westwards for its entire length including the turning head, a distance of 60 metres
U71693 Greenland Avenue	-	From its junction with the B1135 Tuttles Lane East north-eastwards (including both lengths of the bifurcated carriageway) to its junction with the U71694/U7P806 Lavender Road - From its junction with the U71694/U7P806 Lavender Road south-eastwards and north-eastwards to its junction with the U71734 Snowdrop Street
U71719 Honeysuckle Square	-	From its junction with the U71693 Greenland Avenue north-westwards, north-eastwards and south - eastwards to its junction with the U71734 Snowdrop Street
U71740 Laburnum Close	-	From its junction with the U71734 Snowdrop Street southwards and eastwards for its entire length
U71694/U7P806 Lavender Road	-	From its junction with the U71693 Greenland Avenue north-westwards, westwards and northwards to its junction with the U7P808 Rugby Road, including the turning head
U71712 Lobelia Close	-	From its junction with the U71696 Clematis Way for its entire length including the turning heads
U71713 Lupin Close	-	From its junction with the U71696 Clematis Way for its entire length including the turning heads
U71739 Pelargonium Drive	-	From its junction with the U71719 Honeysuckle Square north-eastwards, eastwards, south-eastwards and southwards to its junction with the U71734 Snowdrop Street
U71741 Petunia Court	-	From its junction with the U71734 Snowdrop Street eastwards and north-westwards over its entire developed length including its turning heads
U7P808 Rugby Way	-	From its junction with the U7P807 Twickenham Avenue for its entire length including turning heads a distance of 225 metres
U71695 Salvia Close	-	From its junction with the U71693 Greenland Avenue southwards for its entire length including turning heads
U71734 Snowdrop Street	-	From its junction with the U71693 Greenland Avenue north-eastwards, south-eastwards, north-eastwards and south-eastwards to its junction with the B1172 Norwich Road
U7P807 Twickenham Avenue	-	From its junction with the U71694/U7P806 Lavender Road northwards for its entire length including turning heads, a distance of 165 metres
U71718 Verbena Drive	-	From its junction with the U71697 Crocus Street northwards for its entire length including the turning heads
U71698 Verbena Drive	-	From its junction with the U71694/U7P806 Lavender Road northwards including the turning head

U71735 Wisteria Drive	-	From its southern most junction with the U71739 Pelargonium Drive to its north-eastern most junction with the U71739 Pelargonium Drive
