

THE NORFOLK COUNTY COUNCIL (NORTH WALSHAM, VARIOUS ROADS)
(ONE-WAY) CONSOLIDATION ORDER 2011

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1) to (3) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Save as provided in Article 2 of this Order no person shall, except upon the direction of or with the permission of a police constable in uniform cause or permit any vehicle to proceed along any length of road specified in Column 1 of the Schedule to this Order in any direction other than in the direction specified in Column 2 of the Schedule to this Order.
2. Nothing in Article 1 of this Order shall apply to the driving of any mechanical road cleansing vehicle.
3. This Order shall come into operation on the 7th day of November 2011 and may be cited as The Norfolk County Council (North Walsham, Various Roads) (One-Way) Consolidation Order 2011.
4. The following Orders will become revoked on the date of commencement of this Order as follows:-

“The County of Norfolk (North Walsham)(Traffic Regulation) Order 1977” – Schedule 1 of that Order;

“The Norfolk County Council (North Walsham, Church Street)(One-Way) Order 2004” – in its entirety;

“The County of Norfolk (North Walsham)(Traffic Regulation)(No 1) Order 1962” – Schedule 1 of that Order;

“The Norfolk County Council (Vicarage Street, North Walsham)(One-Way) Order 1987” – in its entirety.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
