

**THE NORFOLK COUNTY COUNCIL  
(NORTH WALSHAM, C557 CHURCH STREET/  
KINGS ARMS STREET/MARKET PLACE/MARKET STREET)  
(PROHIBITION OF WAITING, LOADING AND UNLOADING –  
RESTRICTED ZONE) ORDER 2023**

---

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (North Walsham, C557 Church Street/Kings Arms Street/Market Place/Market Street) (Prohibition of Waiting, Loading and Unloading – Restricted Zone) Order 2023 and shall come into effect on the 13<sup>th</sup> day of March 2023.

2. In this Order –

Any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

“authorised loading bay” means any loading bay signed on a road and authorised or designated by an order made or having effect as if made under the Act:

"authorised taxi rank" means any area of carriageway which is comprised within and indicated by a road marking complying with diagram 1028.2 in Part 4 of Schedule 7 to the Traffic Signs Regulations and General Directions 2016;

"authorised parking place" means any parking place on a road authorised or designated by an order made or having effect as if made under the 1984 Act;

“Civil Enforcement Officer” has the same meaning as in s76 of the 2004 Act;

“Driver” in relation to a vehicle waiting in contravention of an Order, means the person driving the vehicle at the time it was left at that contravention;

“General Directions” shall mean The Traffic Signs Regulations and General Directions 2016”;

“General Regulations” shall mean The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022”;

"Hackney Carriage" has the meaning as in Section 38 of the Town Police Clauses Act 1847;

“Penalty Charge” has the same meaning as in Section 2 of the General Regulations 2007;

“Penalty Charge Notice” has the same meaning as in Section 8 of the General Regulations 2007.

3. The Norfolk County Council (North Walsham, Market Place) (Prohibition of Waiting, Loading and Unloading – Restricted Zone) Consolidation Order 2011 is hereby revoked on the date of commencement of this Order.
4. Save as provided in Article 5 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle to wait, load or unload at any time along the lengths of road specified in Schedule 1 to this Order.
5. Nothing in Article 4 of this Order shall prohibit a person to cause or permit any vehicle to wait in the lengths of road or on the side of roads referred to therein for so long as may be necessary to enable –
  - (a) a person to board or alight from the vehicle;
  - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely -
    - (i) building, industrial or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of the said lengths of road or side of roads; or
    - (iv) the laying, erection, alteration or repair in, or in land adjacent to, the said lengths of road or side of roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
    - (v) the provision of a universal postal service as defined in the Postal Services Act 2011;
  - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties.
6. Nothing in Article 4 of this Order shall apply to any vehicle owned by a funeral director or owner of funeral vehicles when in use as part of a funeral cortege.
7. Nothing in Article 4 of this Order shall prohibit a person to cause or permit any vehicle -
  - (a) to wait upon an authorised parking place or loading bay as set out in Schedule 2 of this Order and in The Norfolk County Council (North Walsham, Various Roads) (Street Parking Places) Variation and Consolidation Order 2011 and The Norfolk County Council (North

Walsham, Various Roads) (Loading Bay) Variation and Consolidation Order 2011; or

- (b) being a hackney carriage, to wait upon an authorised taxi rank.
8. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
9. Insofar as any provision of this Order conflicts with the effect of markings placed on the carriageway and signs as specified in Schedule 14 of the General Directions conveying the existence of:-
- (a) a 'bus stop/clearway'; or
- (b) (i) a toucan or equestrian crossing; or
- (ii) Zebra Pedestrian Crossing or Zebra controlled area; or
- (iii) Pelican Pedestrian Crossing or Pelican controlled area; or
- (iv) Puffin Pedestrian Crossing or Puffin controlled area;

and established as specified in s23(2) of the 1984 Act, the effect of those markings shall prevail.

SCHEDULE 1

Prohibition of Waiting, Loading or Unloading – At Any Time

C558 Church Street Both Sides	From its junction with C557 Market Place to its junction with C558 Bacton Road.
C561 Kings Arms Street Both Sides	From its junction with C557 Market Place southwards for a distance of 13 metres.
C557 Market Place Both Sides	From its junction with C557 Market Street to its junction with C592 New Road.
C557 Market Street Both Sides	From its junction with C560 Mundesley Road to its junction with C557 Market Place.
U10325 Hall Lane Both Sides	From its junction with C558 Church Street eastwards for a distance of 31 metres.
