

**NORFOLK COUNTY COUNCIL  
(NORWICH, CENTRAL PEDESTRIANISED AREAS)  
EXPERIMENTAL AMENDMENT TRAFFIC REGULATION ORDER 2022.**

The Norfolk County Council in exercise of powers under sections 1, 2, 4 and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

Citation and Commencement

1. This Order may be cited as the Norfolk County Council (Norwich, Central Pedestrianised Areas) Experimental Amendment Traffic Regulation Order 2022 and comes into effect for all purposes on the 18<sup>th</sup> day of November 2022.
2. This Order shall remain in force for a period of 18 months.
3. This Norfolk County Council (Norwich, Central Pedestrianised Areas) Experimental Amendment Traffic Regulation Order 2022 dated 19<sup>th</sup> May 2022 is revoked in its entirety on the commencement date of this Order.
4. The Norfolk County Council's Executive Director of Community and Environmental Services, or a person authorised by him, is hereby empowered to modify or suspend the operation of this Order to the extent permitted by section 10 of the Act.
5. The Norwich City Council (Central Pedestrianised Areas) Traffic Regulation Order 2000 (hereinafter referred to as the "2000 Order") is amended as specified in Articles 5 to 9 this Order.
6. Article 5(a) of the 2000 Order is amended to read as follows:
  - "5. Save as provided in Articles 8 and 9 of this Order, no person shall, except on the direction of a Police Constable in uniform, drive or cause or permit to be driven any motor vehicle:
    - (a) between the times of 00.01 hours and 10.00am and between 4.00pm and 12.00 midnight on any day, except Easter Sunday and Christmas Day, on any of the lengths of road specified in Schedule 3 to this Order;"
7. The following wording is inserted in Article 5 after 5(d):-
  - "(e) requiring access to or egress from private parking areas for staff accessing Norfolk House, NR2 1DD."
8. The following paragraphs are added as Articles 14 and 15 to the 2000

Order:-

- “14. Save as provided in Article 15 of this Order no person shall, except on the direction of a Police Constable in uniform, drive or cause or permit to be driven or propelled any motor vehicle at any time on any of the lengths of road specified in Schedule 8 to this Order.”
- “15. Nothing in Article 14 of this Order shall prevent any person from causing or permitting any vehicle to be driven or to wait at any time in any of the lengths of the road referred to in Schedule 8 for the following purposes:
- (i) it is being used in connection with a funeral;
  - (ii) it is being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or telecommunications provided the vehicle cannot be conveniently used for such purpose in any other road;
  - (iii) it is being used in an emergency by a medical practitioner or for fire brigade, ambulance, police or civil defence purposes.
  - (iv) to enable goods or merchandise to or from premises adjoining the said lengths of road to be loaded on to or unloaded from the vehicle;
  - (v) for the purpose of delivering or collecting postal packets;
  - (vi) to enable access for a marked bullion vehicle to load or unload its contents to or from premises adjoining the said lengths of road for the time necessary to carry out said act;
  - (vii) to access or egress private parking areas adjacent to those lengths or road.
9. Schedules 1 to 7 inclusive of the 2000 Order are replaced with Schedules 1 to 6 of this Order.
10. A Schedule 8 is added to the 2000 Order containing the details specified in Schedule 7 to this Order.
11. Insofar as any provision of this Order conflicts with any previous Order relating to the lengths of roads specified in the Schedules to this Order, that provision of this Order shall prevail.

Schedule 7 of the 2000 Order

Motor vehicles must exit Lobster Lane into Bedford Street, unless loading on Exchange Street in permitted hours.

Motor vehicles must exit Opie Street eastbound onto Castle Meadow.

Motor vehicles enter and exit Lion and Castle Yard via Timberhill.

Motor vehicles exit Timberhill and Orford Street into Orford Hill.

Motor vehicles enter Orford Hill from Orford Street or Timberhill.

Motor vehicles exit White Lion Street into Gentleman's Walk or Haymarket.  
 Motor vehicles enter and exit the western section of Davey Place via Gentleman's Walk.  
 Motor vehicles enter Hay Hill from the pedestrianized section of St Peters Street. Motor vehicles enter and exit Weavers Lane via Hay Hill.  
 Motor vehicles exit Hay Hill into Haymarket.  
 Motor vehicles may enter Haymarket from Brigg Street, Orford Place, Hay Hill, White Lion Street or Gentleman's Walk.  
 Motor vehicles may exit Haymarket into Brigg Street, Orford Place or Gentleman's Walk.  
 Motor vehicles may enter Castle Street from the western section of London Street.  
 Motor vehicles enter and exit Old Post Office Court via Castle Street.  
 Motor vehicles enter and exit the eastern section of Davey Place via Castle Street.  
 Motor vehicles may exit Castle Street into Arcade Street or the western section of London Street.  
 Motor vehicles enter Little London Street from Bedford Street.  
 Motor vehicles exit Little London Street into London Street.  
 Motor vehicles exit Bedford Street into London Street.  
 Motor vehicles exit St Andrews Hill into Bedford Street.  
 Motor vehicles enter the central section of London Street from Bedford Street.  
 Motor vehicles exit the central section of London Street into Opie Street.  
 Motor vehicles enter Opie Street from the central section of London Street.  
 Motor vehicles enter and exit the alley connecting Bridewell Alley and St Andrews Hill located between St Andrew's Church and Bridewell Museum via St Andrews Hill.  
 Motor vehicles enter Dove Street from Guildhall Hill.  
 Motor vehicles exit Dove Street via St John Maddermarket.  
 Motor vehicles exit Upper Goat Lane into St Giles Street.  
 Motor vehicles enter and exit Fishers Lane via Pottergate.  
 Motor vehicles enter Lobster Lane from Pottergate.  
 Motor vehicles exit Pottergate into St John Maddermarket or Upper Goat Lane.  
 Facilities and estates staff accessing/egressing the private parking areas of Norfolk House, NR2 1DD between 10am and 4pm should enter Exchange Street via Pottergate.  
 Disabled students/staff/visitors accessing one of the designated disabled spaces at Norfolk House, NR2 1DD between 10am and 4pm should enter Exchange Street via Pottergate.


