

**THE NORFOLK COUNTY COUNCIL
(LODDON AND CHEDGRAVE, VARIOUS ROADS)
(20 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2019**

The Norfolk County Council in exercise of its powers under Section 84 and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as the Norfolk County Council (Loddon and Chedgrave, Various Roads) (20 m.p.h. Speed Limit) Consolidation Order 2019 and shall come into effect on the 14th day of October 2019.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The following Orders will become revoked on the date of commencement of this Order as follows:-

 "The Norfolk County Council (Loddon and Chedgrave, Various Roads) (20 m.p.h. Speed Limit) Order 2013"

 "The Norfolk County Council (Loddon and Chedgrave, Various Roads) (20 m.p.h. Speed Limit) Amendment Order 2018"
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

7P318/10 Brownes Grove	-	From its junction with 7P317/10 Towns Farm Drive for its entire length including its turning head

U76484 Crossway Terrace	-	From its junction with the C203 Kittens Lane northwards for a distance of 77 metres (to the bollards situated across the highway)
U76501 Davey Place	-	For its entire length
U76490 Drury Lane	-	For its entire length
C203 George Lane	-	From its junction with the C554 High Street south-westwards for a distance of 122 metres
C395 High Bungay Road	-	From its junction with the C203 Kittens Lane southwards to a point 20 metres north of its junction with the U71241 Beech Close
U76485 Hobart Road	-	For its entire length
C203 Kittens Lane	-	From its junction with the C554 High Street, westwards to its junction with C203 George Lane
U76333 Low Bungay Road	-	For its entire length
7P319/10 Reeds Way	-	From its junction with 7P317/10 Towns Farm Drive for its entire length including its turning head
7P317/10 Towns Farm Drive	-	From its junction with C554/62 Beccles Road to its junction with 7P319/10 Reeds Way
