

**THE NORFOLK COUNTY COUNCIL (BURNHAM MARKET, VARIOUS ROADS)
(30 M.P.H. SPEED LIMIT) ORDER 2015**

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule below, at a speed exceeding 30 m.p.h.
2. The following Orders will become revoked on the date of commencement of this Order as follows:-
 - "The Norfolk County Council (Burnham Market, B1155 and C99)(30 m.p.h. Speed Limit) Order 1999" – in its entirety;
 - "The Norfolk County Council (Burnham Market, Bellamy's Lane)(30 m.p.h. Speed Limit) Order 2006" – in its entirety;
 - "The Norfolk County Council (Burnham Market and Burnham Norton)(30 m.p.h. Speed Limit) Order 1996" – in its entirety;
 - "The Norfolk County Council (Burnham Market)(30 m.p.h. Speed Limit) Order 1991" – in its entirety.
3. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This Order comes into operation on the 30th day of October 2015 and may be cited as The Norfolk County Council (Burnham Market, Various Roads)(30 m.p.h. Speed Limit) Order 2014.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

| U22369 Beacon Hill | - From its junction with the U22243 Back Lane for its entire length |
| C479 Beacon Hill Road | - From its junction with the B1355 Creake Road southwards to a point 93 metres south-west of the centreline of its junction with the U23368 Kestrel Close |
| B1355 Bellamy's Lane | - From a point 70 metres north of its junction with the B1155 North Street northwards for a distance of 160 metres |
| B1155 Church Walk | - From a point 85 metres south-west of its junction with the U22349 Market Place south-westwards to its junction with the B1155 Docking Lane |
| B1355 Creake Road | - From a point 60 metres south of its junction with the C97 Joan Shorts Lane southwards to a point 350 metres south-east of the centreline of its junction with the C479 Beacon Hill Road |
| U22399 Crofts Close | - From its junction with the U22369 Beacon Hill for its entire length |
| B1155 Docking Road | - From the eastern boundary of its junction with the C99 Whiteway Road south-westwards for a distance of 420 metres |
| U22168 Friars Lane | - From its junction with the B1155 Overy Road northwards and north-westwards to a point 100 metres south-east of its junction with the B1355 Bellamy's Lane |
| U22165 Herrings Lane | - From a point 54 metres north of its junction with the U22349 Market Place northwards to its junction with Burnham Market Restricted Byway 8 known as Cross Lane |
| U23368 Kestrel Close | - From its junction with the C479 Beacon Hill Road for its entire length |

- U23275 Mill Green - From its junction with the B1355 Bellamy's Lane for its entire length
- B1155 Overy Road/
Burnham Road - From a point 101 metres south-west of its junction with the U22169 Joan Shorts Lane north-eastwards to a point 90 metres east of its junction with the U22168 Friars Lane
- U22395 Sutton Lea Estate - From its junction with the U22369 Beacon Hill for its entire length
- C99 Whiteway Road - From its junction with the B1155 Docking Road/Church Walk north-westwards for a distance of 200 metres
