THE NORFOLK COUNTY COUNCIL (HAINFORD)

(30 M.P.H., 40 M.P.H. AND 50 M.P.H. SPEED LIMITS) ORDER 2000

The Norfolk County Council in exercise of its powers under Sections 82(2), 83(2) and 84(1) and (2), and part III of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 1 to this Order at a speed exceeding 30 m.p.h.
- 2. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 2 to this Order at a speed exceeding 40 m.p.h.
- 3. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 3 to this Order at a speed exceeding 50 m.p.h.
- 4. This Order comes into operation on the 20th day of October, 2000, and may be cited as The Norfolk County Council (Hainford)(30 m.p.h., 40 m.p.h. and 50 m.p.h. Speed Limits) Order 2000.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
