THE NORFOLK COUNTY COUNCIL (FRITTON AND ST OLAVES, VARIOUS ROADS) (30 M.P.H. SPEED LIMIT) ORDER 2012

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule below, at a speed exceeding 30 m.p.h.
- 2. The following Orders will become revoked on the date of commencement of this Order as follows:-
 - "The Norfolk County Council (Fritton)(30 m.p.h. Speed Limit) Order 1996" in its entirety;
 - "The Norfolk County Council (A143 Fritton & St Olaves/Haddiscoe)(30 m.p.h. and 40 m.p.h. Speed Limit) Order 1998" in its entirety;
 - "The Norfolk County Council (Fritton, Church Lane)(30 m.p.h. Speed Limit) Order 2004" in its entirety.
- 3. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 4. This Order comes into operation on the 11th day of January 2013 and may be cited as The Norfolk County Council (Fritton and St Olaves, Various Roads)(30 m.p.h. Speed Limit) Order 2012.
- 5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE -

In the Parish of Fritton and St Olaves

30 m.p.h. Speed Limit

A143 Beccles Road

- From a point 152 metres east of the centreline of its junction with the B1074 Herringfleet Road southwestwards to a point 160 metres south-west of the centrepoint of St Olaves Bridge
- From a point 242 metres south-east of its junction with the U61912 New Road north-eastwards to a point 366 metres north-east of its junction with its eastern junction with the U61853 Church Lane

U61853 Church Lane

From its junction with the A143 Beccles Road eastwards for a distance of 350 metres

U61912 New Road

From its junction with the A143 Beccles Road northwards for a distance of 620 metres
