

**The Norfolk County Council
(Walsoken and West Walton Various Roads)
(50 mph Speed Limit) Consolidation and Variation Order 2025**

The Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as The Norfolk County Council (Walsoken and West Walton Various Roads) (50 mph Speed Limit) Consolidation and Variation Order 2025 and shall come into effect on the 8th day of September 2025.
2. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule to this Order at a speed exceeding 50 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The Norfolk County Council (Walsoken and West Walton) (50 m.p.h Speed Limit) Order 2007 and The Norfolk County Council (Walsoken, Various Roads) (50 m.p.h Speed Limit) Order 2009 are hereby revoked in their entirety.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.

Schedule

In the Parishes of Walsoken and West Walton


50 mph Speed Limit

U21105 Bucksholt Road		from its junction with B198 Lynn Road northwards for a distance of 45 metres.
U22106 Burrett Road	-	from its junction with B198 Lynn Road southwards to its junction with C14 Black Bear Lane.
U23579 Fengate Road		from its junction with the U21109 Wheatley Bank for its entire length.
U21104 Grassgate Lane	-	for its entire length.
U21514 Lynn Road	-	for its entire length.
B198 Lynn Road	-	from a point 37 metres southwest of the centreline of its junction with the U21104 Grassgate Lane (southern end) north-eastwards to its junction with A47.
C570 Lynn Road	-	from its junction with B198 Lynn Road northwards for a distance of 25 metres.
U21108 Sparrowgate Road		From its junction with the C14 Black Bear Lane southwards for 340 metres.
U21109 Wheatley Bank	-	from its junction with B198 Lynn Road for its entire length.
