

THE NORFOLK COUNTY COUNCIL (ATTLEBOROUGH, VARIOUS ROADS)
(40 M.P.H. SPEED LIMIT) ORDER 2013

The Norfolk County Council in exercise of their powers under Section 84(1) and (2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 40 miles per hour.
2. The following Orders will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Attleborough)(30 m.p.h. and 40 m.p.h. Speed Limits) Order 1999" – Schedule 2 of that Order;

"The Norfolk County Council (Attleborough, Hargham Road)(40 m.p.h. Speed Limit) Order 2005" – in its entirety'

"The Norfolk County Council (Attleborough, London Road)(40 m.p.h. Speed Limit) Order 2009" – in its entirety;

"The Trunk Roads (40 m.p.h. Speed Limit)(No 10) Order 1967" – in its entirety;

"The Norfolk County Council (Attleborough)(Speed Limits) Order 1991" – Schedule 2 in its entirety.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This Order comes into operation on the 12th day of July 2013, and may be cited as The Norfolk County Council (Attleborough, Various Roads) (40 m.p.h. Speed Limit) Order 2013.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE

In the Town of Attleborough

40 m.p.h. Speed Limit

- B1077 Buckenham Road - From a point 210 metres south of its junction with the U33127 Slough Lane southwards to a point 265 metres south of its junction with the U33089 Borough Lane

- U33089 Borough Lane - From its junction with the B1077 Buckenham Road eastwards for a distance of 160 metres
- C153 Hargham Road - From a point 75 metres south-west of its junction with the U11324 New Road south-westwards for a distance of 717 metres
- U33147 Hillsend Lane - For its entire length
- B1077 Norwich Road - From a point 520 metres north-east of its junction with the B1077 Church Street north-eastwards to a point 55 metres north-east of its junction with the U33096 Mill Lane
- C572 London Road - From a point 48 metres south-west of the centreline of its junction with the C137 West Carr Road south-westwards to a point 303 metres south-west of its junction with the U33124 New Road
