

The City of Norwich (Southern Area) (Prohibition and Restriction of Waiting)  
(Consolidation) Order, 1982

The City Council of Norwich (hereinafter referred to as "the Council") pursuant to arrangements made under Section 101 of the Local Government Act, 1972 with Norfolk County Council in exercise of the powers of the said County Council under Sections 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968 and Schedule 19 to the Local Government Act, 1972 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the Act of 1967 hereby make the following Order:-

1. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait at any time in the lengths of road specified in Schedule 1 to this Order.
2. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 7.0 pm, in any of the lengths of road specified in Schedule 2 to this Order.
3. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm in any of the lengths of road specified in Schedule 3 to this Order.
4. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 8.0 pm, Monday to Saturday, in any of the lengths of road specified in Schedule 4 to this Order.
5. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 7.0 pm, Monday to Saturday, in any of the lengths of road specified in Schedule 5 to this Order.
6. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm, Monday to Saturday, in any of the lengths of road specified in Schedule 6 to this Order.
- 7.. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 10.00am and 12.00 noon, Monday to Friday, in any of the lengths of road specified in Schedule 7 to this Order.
8. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm, from 1st May to 30th September inclusive, in any

of the lengths of road specified in Schedule 8 to this Order.

9. Save as provided on Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm Monday to Saturday in the lengths of road specified in Schedule 9 to this Order:-

- (a) for a period longer than 30 minutes; or
- (b) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of the road or in that length of road.

10. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 7.0 pm in the lengths of road specified in Schedule 10 to this Order:-

- (a) for a period longer than 45 minutes; or
- (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of the road or in that length of road.

11. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm Monday to Saturday in the lengths of road specified in Schedule 11 to this Order:-

- (a) for a period longer than 1 hour; or
- (b) if a period of less than two hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of the road or in that length of road.

12. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm in the lengths of road specified in Schedule 12 to this Order:-

- (a) for a period longer than two hours; or
- (b) if a period of less than four hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of the road or in that length of road.

13. Save as provided in Articles 14 and 15 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.0 am and 6.30 pm Monday to Saturday in the lengths of road specified in Schedule 13 to this Order:-

- (a) for a period longer than two hours; or

- (b) if a period of less than four hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of the road or in that length of road.

14. Nothing in Articles 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 of this Order shall render it unlawful to cause or permit any vehicle to wait in the length of road referred to in that Article, as the case may be, for so long as may be necessary:-

- (a) to enable a person to board or alight from the vehicle;
- (b) to enable goods to be loaded on to or unloaded from the vehicle;
- (c) to enable the vehicle, if it is in the service of or employed by the Post Office, to be used for the purposes of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
- (d) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to or the laying, erection, alteration or repair in or near the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic line as defined in the Telegraphic Act, 1878;
- (e) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in the service of a local authority in pursuance of statutory powers or duties;
- (f) to enable the vehicle to be loaded or unloaded while it is in actual use in connection with the removal of furniture from one office or dwellinghouse to another, or the removal of furniture from such premises to a depository or to such premises from a depository;
- (g) to enable the vehicle to be used in connection with weddings and funerals.

15. Nothing in Articles 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 of this Order shall prevent any person from causing or permitting any vehicle to be driven in any of the lengths of road referred to in those Articles to enable the vehicle to be used:-

- (i) by disabled drivers provided that the vehicle is -
  - (a) a power assisted invalid carriage;
  - (b) a vehicle issued to a disabled person by the Department of Health and Social Security in lieu of an invalid carriage;
- (ii) a disabled person's vehicle which displays in the relevant position a disabled person's badge issued by any local authority in accordance with the provisions of the Disabled Persons (Badge for Motor Vehicles) Regulations, 1975 or a badge having effect under those regulations as if it were a disabled person's badge.

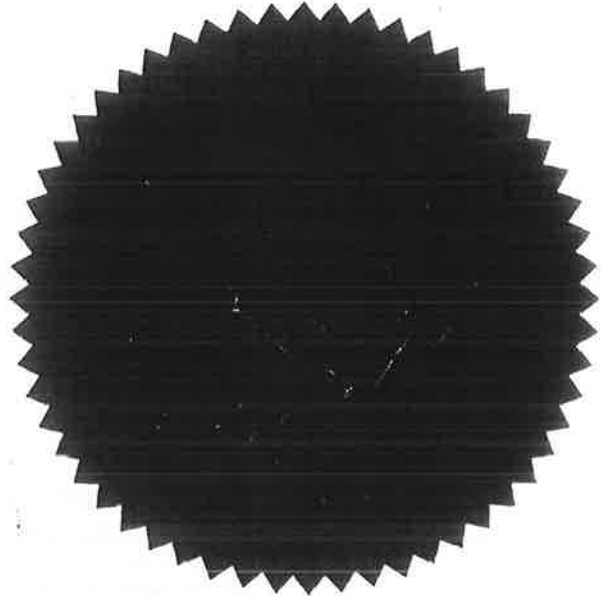
16. The Orders specified in Schedule 14 to this Order are hereby revoked.
