

THE NORFOLK COUNTY COUNCIL (TACOLNESTON)

(30 M.P.H. SPEED LIMIT) ORDER 2002

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and part III of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
2. The following Orders will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Tacolneston)(30 m.p.h. Speed Limit) Order 1996" – in its entirety; 2027 ✓

"The County Council of Norfolk (40 m.p.h. Speed Limit)(No 2) Order 1979" – in its entirety. 783 ✓
3. This Order comes into operation on the 1st day of November 2002 and may be cited as The Norfolk County Council (Tacolneston) (30 m.p.h. Speed Limit) Order 2002.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
