## THE NORFOLK COUNTY COUNCIL (REDENHALL WITH HARLESTON, VARIOUS ROADS) (30 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2009

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule below, at a speed exceeding 30 m.p.h.
- 2. The following Order will become revoked on the date of commencement of this Order and its schedule consolidated into this Order as follows:-
  - "The Norfolk County Council (Redenhall with Harleston)(30 m.p.h. Speed Limit) Order 1996" in its entirety.
- This Order comes into operation on the 27<sup>th</sup> day of March 2009 and may be cited as The Norfolk County Council (Redenhall with Harleston, Various Roads)(30 m.p.h. Speed Limit) Consolidation Order 2009.
- Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
