THE NORFOLK COUNTY COUNCIL (A149 BETWEEN CROMER & KELLING)  
(30 AND 40 M.P.H. SPEED LIMITS) ORDER 1994

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 1 to this Order at a speed exceeding 40 m.p.h.
2. No person shall cause any vehicle to proceed in the lengths of road specified in Schedule 2 to this Order at a speed exceeding 30 m.p.h.
3. This Order comes into operation on the 11th day of November 1994, and may be cited as The Norfolk County Council (A149 between Cromer & Kelling) (30 and 40 m.p.h. Speed Limits) Order 1994.
4. Insofar as any provision of This Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedules to this Order, that provision of this Order shall prevail.

SCHEDULE 1

A149 Cromer Road in the Parishes of Cromer and Runton

From a point 27 metres west of the centre line of Shipden Avenue, Cromer, westwards, to a point 254 metres east of the centre line of Beach Road, Runton.

A149 Cromer Road in the Parish of Runton

From a point 19 metres west of the centre line of Thain's Lane, westwards, to a point 8 metres east of the centre line of Boulevard Road.

A149 Cromer Road in the Parishes of Beeston Regis and Sheringham,

From a point adjacent to the eastern boundary of the vehicular access to the playing field, Beeston Regis, westwards, to a point 11 metres east of the centre line of Brook Road, Sheringham.

A149 Weybourne Road in the Parish of Sheringham

From a point 45 metres west of the centre line of the access to Sheringham Golf Club, westwards, to a point 15 metres west of the centre line of the entrance to Sheringham Cemetery, a distance of 408 metres.

SCHEDULE 2

A149 In the Parish of Kelling

From a point 160 metres east of the centre line of Meadow Lane, westwards, for a distance of 425 metres.

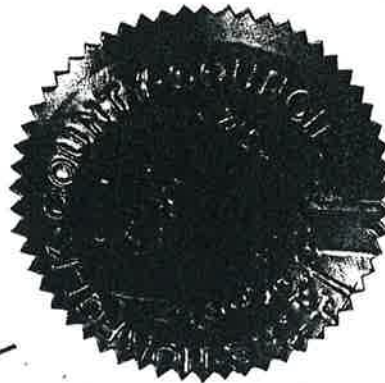
