

**THE NORFOLK COUNTY COUNCIL (ATTLEBOROUGH, VARIOUS ROADS)  
(30 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2019**

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Attleborough, Various Roads) (30 m.p.h. Speed Limit) Consolidation Order 2019 and shall come into operation for all purposes on the 14<sup>th</sup> day of October 2019.
2. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 30 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The following Orders will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Attleborough, Hillsend Lane, London Road) (30 m.p.h. Speed Limit) Amendment Order 2018"

5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

U33126 Leys Lane	-	From its junction with the C157 Hargham Road southwards to its southernmost end
C572 London Road	-	From its junction with the U33121 Chapel Road south-westwards to a point 387 metres south of its junction with the U33124 New Road
U33096 Mill Lane	-	From its junction with the B1077 Norwich Road to its junction with the C572 Silver Street
U33124 New Road	-	From its junction with the C153 Hargham Road to its junction with the C572 London Road
B1077 Norwich Road	-	From its junction with the B1077 Church Street north-eastwards for a distance of 520 metres
C572 Silver Street	-	From its junction with the C139 Besthorpe Road eastwards to a point 180 metres east of its junction with the U33096 Mill Lane
U33127 Slough Lane	-	From its junction with the B1077 Buckenham Road westwards for a distance of 125 metres
B1077 Surrogate Street	-	From its junction with the B1077 Norwich Road to its junction with the B1077 Connaught Road
B1077 Station Road	-	From its junction with the B1077 Connaught Road to its junction with the B1077 Buckenham Road
U33176 Thieves Lane	-	From its junction with the B1077 Surrogate Street eastwards to its junction with the C139 Besthorpe Road
U33116 Warren's Lane	-	From its junction with the B1077 Ellingham Road southwards and westwards for a distance of 150 metres
C137 West Carr Road	-	From its junction with the C572 London Road to a point 54 metres west of its junction with the U33119 Carver's Lane
