

**THE NORFOLK COUNTY COUNCIL (BARNHAM BROOM)  
(30 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2019**

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Barnham Broom) (30 m.p.h. Speed Limit) Consolidation Order 2019 and shall come into operation for all purposes on the 7<sup>th</sup> day of October 2019.
2. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 30 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The following Orders will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Barnham Broom) (30 m.p.h. Speed Limit) Order 2000"

"The Norfolk County Council (Barnham Broom, Bell Road) (30 m.p.h. Speed Limit) Amendment Order 2019"

5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.


**SCHEDULE**  
**In the Parish of Barnham Broom**

**30 m.p.h. Speed Limit**

U76016/14 Bell Road	- From a point 160 metres south of its junction with U78271 Mill View northwards to a point 115 metres north of its junction with C162 Norwich Road
U78423 Chapel Close	- For its entire length
U78390 Hillside	- For its entire length
C162 Mill Road/ Norwich Road	- From a point 25 metres west of the western boundary of Bridge House eastwards to a point 130 metres north-east of the boundary of the telephone exchange property
U78271 Mill View	- For its entire length
U78198 Spur Road	- From its junction with C162 Norwich Road in a south-east direction for a distance of 175 metres
