

THE NORFOLK COUNTY COUNCIL (WYMONDHAM, VARIOUS ROADS)
(30 M.P.H. SPEED LIMIT) CONSOLIDATION ORDER 2015

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and (2) and 85(2) and (4) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule below, at a speed exceeding 30 miles per hour.
2. The following Orders will become revoked and consolidated with this Order on the date of commencement of this Order as follows:-
 - ✓ "The Norfolk County Council (Wymondham, Cemetery Lane)(30 m.p.h. Speed Limit) Order 2005" – in its entirety.
 - ✓ "The Norfolk County Council (Wymondham)(30 m.p.h. Speed Limit) Order 1984" – in its entirety.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This Order comes into operation on the 24th day of April 2015 and may be cited as The Norfolk County Council (Wymondham, Various Roads)(30 m.p.h. Speed Limit) Order 2015.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
