

THE NORFOLK COUNTY COUNCIL (WYMONDHAM, VARIOUS ROADS)
(40 M.P.H. SPEED LIMIT) ORDER 2015

The Norfolk County Council in exercise of their powers under Section 84(1) and (2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 40 Miles per hour.

2. The following Orders will become revoked and consolidated with this Order on the date of commencement of this Order as follows:-

"The Norfolk County Council (Wymondham, B1172 and U78303 London Road)(40 m.p.h. Speed Limit) Order 2002" – in its entirety;

"The Norfolk County Council (Wymondham)(30 m.p.h. and 40 m.p.h. Speed Limits) Order 2002" – in its entirety;

"The Norfolk County Council (Wymondham)(30 and 40 m.p.h. Speed Limits) Order 1993" – in its entirety;

"The Norfolk County Council (Wymondham)(40 m.p.h. Speed Limit) Order 1984" – in its entirety.

3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.

4. This Order comes into operation on the 24th day of April 2015, and may be cited as The Norfolk County Council (Wymondham, Various Roads) (40 m.p.h. Speed Limit) Order 2015.

5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE

In the Town of Wymondham

40 m.p.h. Speed Limit

C176 Barnham Broom Road

- From its junction with the B1135 Tuttles Lane West, north-westwards for a distance of 412 metres

C700 Chapel Lane

- From a point 85 metres west of its junction with the B1135 Tuttles Lane West eastwards and south-eastwards to its junction with the U78414 Longlands Drive

B1172 Harts Farm Road/
London Road

- From the roundabout at its junction with the B1172 Tuttles Lane East/Falconers Chase south-westwards to a point 36 metres south-west of the centreline of its junction with the U78303 London Road

U78303 London Road

- From its junction with the B1172 London Road westwards to a point 264 metres west of its junction with the B1172 London Road

U71443 Skipping Block Row

- From its junction with the B1172 Norwich Common for its entire length

U78290 Spinks Lane

- From its junction with the B1172 Norwich Common to its southernmost end

B1135/160 Tuttles Lane East



- From the roundabout its junction with the B1172 Harts Farm Road westwards for its entire length (including the entire perimeter of the roundabout at its junction with the B1172 Norwich Road/Norwich Common)

B1135/180 Tuttles Lane East/
B1135/190 Tuttles Lane West

- From a point 75 metres east of its junction with the U71012/Finderne Drive westwards to its junction with the B1135/C700 Chapel Lane
