

**The Norfolk County Council
(Bawburgh, Various Roads)
(20 mph Speed Limit) Consolidation and Variation Order 2025**

Norfolk County Council in exercise of its powers under Sections 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order may be cited as The Norfolk County Council (Bawburgh, Various Roads) (20 mph Speed Limit) Consolidation and Variation Order 2025 and shall come into effect on the 4th day of December 2025.
2. No person shall cause or permit any motor vehicle to proceed along the length of the roads specified in the Schedule to this Order at a speed exceeding 20 miles per hour.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. The Norfolk County Council (Bawburgh) (20 mph Speed Limit) Consolidation Order 2019 is hereby revoked.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

20 mph Speed Limit

U78131 Church Street	From its junction with the C170 Stocks Hill westwards for a distance of 160 metres
U71273 Hall Farm Place	For its entire length
C170 Harts Lane	From its junction with the C170 Stocks Hill north-westwards for a distance of 235 metres
U78079 Hockering Lane	For its entire length (including service road to sewerage works)
U78234 Hockering Lane	For its entire length
U78196 New Road	From its junction with the C170 Stocks Hill eastwards for a distance of 95 metres
C170 Stocks Hill	From its junction with the C170 Harts Lane southwards to a point 490 metres south of its junction with the southern junction of the U78131 Church Street
U78464 Stocks Hill	For its entire length
7P767 Stocks Hill	From the centreline of its junction with the C170 Stocks Hill, westwards for a distance of 66 metres
