

THE NORFOLK COUNTY COUNCIL
(BAWBURGH, COLNEY AND LITTLE MELTON, VARIOUS ROADS)
(40 M.P.H. AND 50 M.P.H. SPEED LIMITS) ORDER 2014

The Norfolk County Council in exercise of their powers under Section 84(1) and (2) and 122 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause or permit any vehicle to proceed along the lengths of road specified in Schedule 1 to this Order at a speed exceeding 40 miles per hour.
2. No person shall cause or permit any vehicle to proceed along the lengths of road specified in Schedule 2 to this Order at a speed exceeding 50 miles per hour.
3. The following Orders will become revoked and consolidated with these proposals on the date of commencement of this Order as follows:-

"The Norfolk County Council (Colney, Watton Road)(40 m.p.h. Speed Limit) Order 2008" – in its entirety;
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces)(Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. This Order comes into operation on the 8th day of August 2014, and may be cited as The Norfolk County Council (Bawburgh, Colney and Little Melton, Various Roads) (40 m.p.h. and 50 m.p.h. Speed Limits) Order 2014.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE 1

In the Parish of Colney and Bawburgh

40 m.p.h. Speed Limit

B1108 Watton Road

- From a point 300 metres east of its junction with the U78470 Old Watton Road (eastern leg of junction) in the parish of Colney westwards to a point 80 metres east of the centreline of its junction with the C772 Green Lane in the parish of Bawburgh

SCHEDULE 2

In the Parishes of Bawburgh and Little Melton

50 m.p.h. Speed Limit

- B1108 Watton Road
- From a point 80 metres east of the centreline of its junction with the C772 Green Lane in the parish of Bawburgh westwards for a distance of 1600 metres
- C772 Green Lane
- From a point 300 metres north-west of its junction with the C169 School Lane in the parish of Little Melton northwards to its junction with the B1108 Watton Road in the parish of Bawburgh
- C170 Stocks Hill
- From a point 490 metres south of its junction with the southern junction of the U78131 Church Street in the parish of Bawburgh south-eastwards to its junction with the B1108 Watton Road in the parish of Bawburgh
