THE NORFOLK COUNTY COUNCIL (BAWDESWELL, VARIOUS ROADS)
(20 M.P.H. SPEED LIMIT) ORDER 2007

The Norfolk County Council in exercise of its powers under Section 84 and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), having given public notice in accordance with sub-section (2) of that section and having consulted the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 to the Act, hereby makes the following Order:

1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
2. The following Order will become revoked on the date of commencement of this Order as follows:-

"The Norfolk County Council (Bawdeswell)(30 m.p.h. Speed Limit) Order 1991" – entries numbered 2. The Street, Foxley Road, 6. Reepham Road (cul-de-sac), 7. Paradise Road, 8. Folland Court, 9. Blackhorse Close, 10. Paradise Lane and 11. Dereham Road in their entirety;
3. This Order shall come into force on the 9th day of February 2007 and may be cited as the Norfolk County Council (Bawdeswell, Various Roads)(20 m.p.h. Speed Limit) Order 2007.
4. Insofar as any provision of this Order conflicts with any provision of any other Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
