THE NORFOLK COUNTY COUNCIL (BANNINGHAM)

(30 M.P.H. AND 40 M.P.H. SPEED LIMITS) ORDER 1998

The Norfolk County Council in exercise of their powers under Sections 82(2), 83(2), 84(1) and 84(2) and part III of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- No person shall cause any vehicle to proceed in the lengths of road specified in 1. Schedule 1 to this Order at a speed exceeding 30 m.p.h.
- No person shall cause any vehicle to proceed in the lengths of road specified in 2. Schedule 2 to this Order at a speed exceeding 40 m.p.h.
- This Order comes into operation on the 19th day of June 1998 and may be cited as The 3. Norfolk County Council (Banningham) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1998.
- Insofar as any provision of this Order conflicts with any provision of any previous 4. Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
