

**THE NORFOLK COUNTY COUNCIL  
(COLBY & FELMINGHAM, VARIOUS ROADS)  
(30 M.P.H SPEED LIMIT) CONSOLIDATION AND VARIATION ORDER 2026**

The Norfolk County Council in exercise of their powers under Section 84 and part IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. This Order may be cited as The Norfolk County Council (Colby & Felmingham, Various Roads) (30 m.p.h. Speed Limit) Consolidation and Variation Order 2026 and shall come into effect on the 5<sup>th</sup> day of January 2026.
2. The Norfolk County Council (Banningham) (30 m.p.h. and 40 m.p.h. Speed Limits) Order 1998 is revoked in its entirety.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 30 miles per hour along the lengths of road specified in the Schedule to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.

**Schedule**

**In the Parishes of Colby and Felmingham**

**30 m.p.h. Speed Limit**

B1145 Aylsham Road/ North Walsham Road	-	From a point 78 metres west of its junction with the U14339/100 Suffield Road westwards for a distance of 1185 metres.
U14235 Banningham Road	-	From C298 Church Road north-westwards for a distance of 27 metres.
U14237 Banningham Road	-	From the centreline of C298 Church Road south-eastwards and eastwards for a distance of 216 metres.
U14240 Bridge Road	-	From C298 Church Road south-east to its junction with the B1145 North Walsham Road.
U14495 Church Close	-	Entire length.
C298 Church Road	-	From a point 68 metres south-west of U14235 Banningham Road north-eastwards, south-eastwards then north-eastwards to a point 197 metres north-east of the centreline of its junction with U14240 Bridge Road.

U14242 Colby Corner	-	From U14240 Bridge Road north-eastwards for a distance of 279 metres.
U14239 Mill Road	-	From B1145 North Walsham Road south-eastwards for a distance of 966 metres.
