

**The Norfolk County Council  
(Coltishall, Rectory Road, Rectory Close, St Johns Close and Westbourne Road)  
(De-Restriction and 20 mph Speed Limit) Order 2026**

The Norfolk County Council in exercise of its powers under Sections 82(2), 83(2), 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereafter 'the Act'), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Coltishall, Rectory Road, Rectory Close, St Johns Close and Westbourne Road) (De-Restriction and 20 mph Speed Limit) Order 2026 and shall come into effect on the 31<sup>st</sup> day of January 2026.
2. No person shall cause or permit any motor vehicle to proceed along the lengths of road specified in the Schedule to this Order at a speed exceeding 20 miles per hour.
3. On the date of commencement of this Order, the lengths of road specified in the Schedule to this Order that are restricted roads, as defined by Section 82 of the Road Traffic Regulation Act 1984, shall cease to be a restricted road.
3. The following Orders will become revoked on the date of commencement of this Order in so far as they relate to the length of the U57134 Rectory Road referred to in the Schedule to this Order:-
  - a. The County Council of Norfolk (Restricted Roads) (No.1) Order 1976; and
  - b. The Norfolk County Council (Coltishall) (30mph Speed Limit) Order 1987.
5. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
6. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

U57492 Rectory Close	-	From its junction with the U57134 Rectory Road for 85 metres eastwards (including turning head).
U57134 Rectory Road	-	From 20 metres north of its junction with the B1354 Church Street for 707 metres northwards.
U51226 St Johns Close	-	From its junction with the U57134 Rectory Road for 161 metres eastwards.
U57135 Westbourne Road	-	From its junction with the U57134 Rectory Road to its junction with the B1150 North Walsham Road.
