THE NORFOLK COUNTY COUNCIL(COSTESSEY, GROVE AVENUE AREA) (20 M.P.H. SPEED LIMIT) ORDER 2000

The Norfolk County Council in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), having given public notice in accordance with subsection (2) of that section and having consulted the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 to the Act, hereby makes the following Order:

- 1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on any of the lengths of road specified in the Schedule to this Order.
- 2. The following Order will become revoked on the date of commencement of this Order as follows:-
 - "The County of Norfolk (Restricted Roads) (No. 1) Order 1965" insofar as it refers to the lengths of road listed in the Schedule to this Order.
- This Order shall come into force on the 20th day of October 2000 and may be cited as the Norfolk County Council (Costessey, Grove Avenue Area) (20 m.p.h. Speed Limit) Order 2000.
- 4. Insofar as any provision of this Order conflicts with any provision of any other Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
