

THE NORFOLK COUNTY COUNCIL
(CRINGLEFORD, BRAMBLING AVENUE, DRAGONFLY LANE, THE PINES)
(20MPH SPEED LIMIT ZONE) ORDER 2024

The Norfolk County Council in exercise of its powers under Sections 84, 122 and 122A and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Cringleford, Brambling Avenue, Dragonfly Lane, The Pines) (20mph Speed Limit Zone) Order 2024 and shall come into effect on the 22nd January 2024.
2. The Norfolk County Council (Cringleford, Various Roads) (20 M.P.H Speed Limit) Order 2016, will become revoked on the date of commencement of this Order.
3. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the schedule to this Order.
4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
5. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.

U71689 / 7P255 Dragonfly Lane	From a point 20m south of its centreline of the southernmost junction with the U7P122 Jasmine Walk, north-eastwards and north-westwards to its junction with the U71803 Brambling Lane (570 metres)
U71803 Brambling Lane	From the centreline of the southernmost junction with the U71689 Dragonfly Lane, westwards and northwards for a distance of 308 metres
U71688 The Pines	From the centreline of its junction with the U71803 Brambling Lane, westwards for a distance of 230 metres
