

**THE NORFOLK COUNTY COUNCIL
(CROMER, VARIOUS ROADS)
(20 MPH SPEED LIMIT ZONE) ORDER 2024**

The Norfolk County Council in exercise of its powers under Sections 84, 122 and 122A and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order may be cited as the Norfolk County Council (Cromer, Various Roads) (20 MPH Speed Limit Zone) Order 2024 and shall come into effect on the 24th June 2024.
2. No person shall cause or permit any vehicle to proceed at a speed exceeding 20 miles per hour along the lengths of road specified in the Schedule to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the length of road specified in the Schedule to this Order, that provision of this Order shall prevail.

SCHEDULE
In the Parish of Cromer

20mph Speed Limit Zone


U11514/10 Burgess Close	-	From the mid-point of its junction with U11511/10 Randall Crescent for 64 metres southwards including turning heads.
U11511/10 Randall Crescent	-	From the mid-point of its junction with U11511/60 Randall Crescent for 85 meters southwards including turning heads.
U11511/10 Randall Crescent	-	From the mid-point of its junction with U11511/40 Randall Crescent for 140 metres eastwards including turning heads.
U11511/20 Randall Crescent	-	From the mid-point of its junction with U11511/40 Randall Crescent for 53 meters eastwards including all turning heads.
U11511/40 Randall Crescent	-	From a point 50 metres south of its junction with U11511/10 Randall Crescent for 87 metres northwards including all turning heads.
U11511/60 Randall Crescent	-	From the mid-point of its junction with C467/22 Roughton Road for 50 metres westwards including all turning heads.

U11510/10 Sayer Crescent	-	From the mid-point of its junction with C467/22 Roughton Road for 51 metres westwards.
U11510/20 Sayer Crescent	-	From the mid-point of its junction with 11510/10 Sayer Crescent for 112 metres southwards including all turning heads.
U11513/10 Vaughan Close	-	From the mid-point of its junction with U11511/10 Randall Crescent for 50 metres southwards including turning head.
U11509/10 Woodcock Road	-	From the mid-point of its junction with U11510/10 Sayer Crescent for 120 meters northwards including turning heads.
U11512/10 Yaxley Loke	-	From the mid-point of its junction with U11511/10 Randall Crescent for 52 metres eastwards including turning heads.
