

THE NORFOLK COUNTY COUNCIL
(DISS, VARIOUS ROADS)
(PROHIBITION OF WAITING) AMENDMENT ORDER 2017

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. Citation and Commencement

This Order may be cited as the "The Norfolk County Council (Diss, Various Roads) (Prohibition of Waiting) Amendment Order 2017 and shall come into effect for all purposes on the 5th day of June 2017.

2. The Norfolk County Council (Diss, Various Roads) (Prohibition of Waiting) Variation and Consolidation Order 2011 is amended by the addition to Schedule 1 of the lengths of roads as specified in the Schedule to this Order.
3. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

Prohibition of Waiting - At Any Time

The following descriptions are inserted:

B1077 Denmark Street South-east side	-	From its junction with the A1066 Park Road for a distance of 71.5 metres north-eastwards
U71073 Field House Gardens Both sides	-	From its junction with the U76272 Frenze Road to a point 39 meters southwards back from the junction line
U76272 Frenze Hall Lane North side	-	From its junction with the U70007 Willbye Avenue to a point 15 metres eastwards from the centre line of its junction with the U70007 Willbye Avenue
U76272 Frenze Hall Lane Both sides	-	From a point 22 metres south-westwards from the centre line of its junction with the U70008 Walcot Rise to a point 19 metres north-eastwards from the centre line of its junction with the 7P273 Prince William Way

U76272 Frenze Road South side	-	From its junction with the U71073 Field House Gardens to a point 48 metres westwards of the centre line of its junction with the U71073 Field House Gardens
U76272 Frenze Road North side	-	From its junction with the U70007 Willbye Avenue to a point 15 metres westwards from the centre line of its junction with the U70007 Willbye Avenue
7P273 Prince William Way Both sides	-	From its junction with the U76272 Frenze Hall Lane to a point 12 metres back from the junction line.
U71597 Sycamore Way Both sides	-	From its junction with the U76272 Frenze Hall Lane to a point 12 metres back from the junction line.
U70008 Walcot Rise Both sides	-	From its junction with the U76272 Frenze Hall Lane to a point 15 metres back from the junction line.
U70007 Willbye Avenue Both sides	-	From its junction with the U76272 Frenze Road and the U76272 Frenze Hall Lane to a point 10 metres back from the junction line.
