THE NORFOLK COUNTY COUNCIL (EASTON)

(30 M.P.H. SPEED LIMIT) ORDER 2004

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) and parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
2. The following Orders will become revoked on the date of commencement of this Order as follows:

"The Norfolk County Council (Marlingford Road, Easton) (30 m.p.h. Speed Limit Extension) Order 1994" - in its entirety; ✓

"The County Council of Norfolk (Restricted Roads) (No.1) Order 1975" - insofar as that Order refers to the Parish of Easton; ✓

"The Trunk Roads (40 m.p.h. Speed Limit) (No 7) Order 1973" - in its entirety; ✕

"The County Council of Norfolk (Restricted Roads) (No 2) Order 1975" - insofar as that Order refers to the Parish of Easton. ✓
3. This Order comes into operation on the 2nd day of April 2004 and may be cited as The Norfolk County Council (Easton)(30 m.p.h. Speed Limit) Order 2004.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
