


**THE NORFOLK COUNTY COUNCIL
(GREAT YARMOUTH (GORLESTON), VARIOUS ROADS)
(STREET PARKING PLACES) AMENDMENT ORDER 2017**

The Norfolk County Council (hereinafter referred to as "the Council") in exercise of their powers under Section 32(1) and 35(1) and 122 and Parts III & IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and the Traffic Management Act 2004 (hereinafter referred to as "the 2004 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order maybe cited as The Norfolk County Council (Great Yarmouth (Gorleston), (Various Roads) (Street Parking Places) Amendment Order 2017 and shall come into operation on the ^{20th}~~22nd~~ day of March 2017. 
2. In Schedule 1 of The Norfolk County Council (Great Yarmouth (Gorleston), Various Roads) (Street Parking Places) Order 2015 references to Bridge Road are amended as set out in the Schedule to this Order.
3. In so far as any provision of this Order conflicts with any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.
