

THE NORFOLK COUNTY COUNCIL (GREAT ELLINGHAM)

(30 M.P.H. SPEED LIMIT) ORDER 1997

The Norfolk County Council in exercise of their powers under Sections 82(2) and 83(2) Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. No person shall cause any vehicle to proceed in the lengths of road specified in the Schedule to this Order at a speed exceeding 30 m.p.h.
- 2. The following Order is hereby revoked insofar as it relates to the lengths of road specified in the Schedule.

The Norfolk County Council (Miscellaneous) (40 and 50 m.p.h. Speed Limits) Consolidation Order 1993. 1765

- 3. This Order comes into operation on the 21st day of March, 1997 and may be cited as The Norfolk County Council (Great Ellingham) (30 m.p.h. Speed Limit) Order 1997.
- 4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

| B1077 Attleborough Road | - | from a point 300 metres west of its junction with the C136 eastwards to a point 275 metres east of its junction with the U33114. Decision C |
| C135 Mill Lane | - | from its junction with the C136 westwards for a distance of 175 metres. |
| C136 Hingham Road | - | from its junction with the B1077 northwards for a distance of 355 metres. |
| C136 Chequers Lane/Long Street | - | from its junction with the B1077 southwards to a point 790 metres south of its junction with the U33112. |
| U33114 DESPWEN Lane | - | from its junction with the B1077 north eastwards for a distance of 90 metres. |
| U33138 Penhill Lane | - | from a point 120 metres west of its junction with the U33112 eastwards and northwards to its junction with the C136. |



- U33139 Church Street - from its junction with the C136 north-eastward to its junction with the B1077.
- U33112 - from its junction with the U33138 eastwards to its junction with the C136.
- U31178 Chequers Green - its entire length.
- U31128 Rectory Lane - from its junction with the C136 eastwards and southwards to its junction with the U33139.
- U31129 Home Close - its entire length.
- U33214 - its entire length.
