

**THE NORFOLK COUNTY COUNCIL**  
**(HOLT, CHURCH STREET, HIGH STREET, OBELISK PLAIN)**  
**(PROHIBITION OF WAITING) AMENDMENT ORDER 2017**

The Norfolk County Council in exercise of their powers under Sections 1(1), 2(1), 2(2) and 4(2) and 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. This Order may be cited as The Norfolk County Council (Holt, Church Street, High Street, Obelisk Plain) (Prohibition of Waiting) Amendment Order 2017 and shall come into effect on the 4<sup>th</sup> day of September 2017.
2. The Norfolk County Council (Holt, Various Roads) (Prohibition of Waiting) Order 2012 (hereinafter referred to as the "2012 Order") is amended as specified in Article 3 of this Order.
3. Schedule 1 of the 2012 Order is amended by the deletion of the reference to Church Street and by the addition of the lengths of road specified in the Schedule of this Order in which no person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait at any time.
4. Insofar as any provision of this Order conflicts with any provision of any previous Order relating to the lengths of road specified in the Schedule to this Order, that provision of this Order shall prevail.

C448 High Street North side	-	From its junction with A148 Letheringsett Hill east for 8 metres.
C448 High Street North side	-	From a point 16 metres east of its junction with A148 Letheringsett Hill east for 7 metres.

*Insert the following references (continued):*

Obelisk Plain (the area adjacent to nos 50-38 High Street) Traffic island	-	Around the perimeter of the traffic island opposite the property 'High Silver' between C448 High Street and the area known as Obelisk Plain.
Obelisk Plain (the area adjacent to nos 50-38 High Street) North side	-	From a point 6.2 metres from the westernmost extent of the carriageway east for 12 metres.
Obelisk Plain (the area adjacent to nos 50-38 High Street) North side	-	From a point 18 metres east of the westernmost end of the carriageway east for 19 metres.
